- As part of its participation at the 24th session of the Conference of the Parties to the United Nations Framework Convention on Climate Change (COP24), [CARRE GEO & ENVIRONNEMENT](#) and its partners are pleased to invite you to the side event on the environmental migration they organize.

- Indeed, migration is exacerbated by economic, cultural, political and environmental reasons. - In this context, decision 49 / CP21 endorses the establishment of a task force to develop recommendations on population displacement caused by climate change. A first version of these recommendations will be presented at COP24. .
- The event aims to bring to the attention of this task force, the recommendations of civil society on environmental migration .

PhD candidate at CRIDEAU (Interdisciplinary Research Center in Environmental Law and Urban Development). Lecturer at the Limoges Faculty of the Law (France) and member of the International Center for Comparative Environmental Law (CIDCE). She will analyse one of the legal instruments that could protect the environmental displaced. In particular, the draft convention on the international status of environmental displaced persons.

Professor of Law at Sungkyunkwan University in Seoul, Korea.

Adviser to the Minister of the Environment and member of the International Center for Comparative Environmental Law. He will critically analyse the notion of common but differentiated responsibility and the polluter pays principle in the context of environmental migration.
